 - "DCI" urban cutlery TM logo's may not be removed and must be visible at all times
 - The cutlery merchandising stand may not be Removed, relocated or abandoned the from the address shown below, unless permission for the removal or relocation of the equipment is requested & approved by "DCI" in writing
 - The "Customer" will notify "DCI" of any action that requires replacement or repairs
 - The "Customer" agrees that the equipment is <u>solely for the merchandising of the products</u> <u>supplied by "DCI"</u> and will only be used for the purposes for which the equipment was designed
- 4. Maintenance, Care of Equipment, Access & Consequential Loss / Indemnity
 - The "customer " must clean & take reasonable care of the equipment and protect it against theft, vandalism & it must be used in accordance with "DCI's" recommendation/s
 - The equipment must be used under the Occupational Health & Safety legislation
 - The "Customer" shall ensure that the equipment is insured against loss, damage or destruction by fire, theft, accident or malicious damage
 - On termination of the loan, or cessation of the business the 'Customer ' shall at their own cost securely pack and return the equipment to the "DCI" office
 - The "Customer" will allow "DCI" & it's authorized agents access to view the equipment during normal trading hours
